On the date 11.11.2022 under general anesthesia she underwent first stage of first round insertion of tissue expanders to right chest wall right upper abdomen, and left chest wall. surgery uneventfull

she underwent serial inflation of the expanders

now admitted for second stage of first round removal of tissue expanders from right and left chest and right abdominal wall, excision of scar tissue and reconstruction with expanded flaps.

PHYSICAL EXAMINATION

Normia vital signs.
Normal ventilation both lungs.
Rhythmic heart sounds
The RT side of the upper chestwall IS HEAVILY SCARRED and covered with STSG. The nipple is present but misplaced inferiorly and medially. The axilla is reconstructed so there is no severe axillary contracture. There is an additional scar on the RT arm and RT thigh (donor site of FTSG).
Explained to Amina's mother that the breast bud is probably injured and the breast is misplaced by scarring.

tissue expanders in right and left chestwalls and right abdominal wall are fully inflated with no infection signs

COURSE

on 31.01.23 under general anesthesia the patient underwent second stage of first round removal of tissue expanders from right and left chest and right abdominal wall, excision of scar tissue and reconstruction with expanded flaps.
3JP drains were inserted.

The surgery and the postoperative course were uneventful, without any adverse complication. On the day of discharge, the girl felt good, she was eating and drinking as expected. On changing of the dressing the surgical wounds seem clean with no bleeding or signs of infection. the drains were removed

Now she is advised to continue follow up in our out-patient clinic with the following recommendation

RECOMMENDATIONS ON DISCHARGE

- * visit our outpatient clinic, please schedule an appointment with Izabel.
- * Local treatment of the wound with xeroform gauze after washing the area thoroughly with soap and water. You are advised to do this treatment once daily for a week.
- * It is highly recommended that you do not expose the wounds to any contaminated water sources, such as sea water or swimming pool water. You should refrain from swimming in these water sources 4 months.
- * In any event of deterioration (such fever, redness, swelling, pain, pus discharge, or any other complaint) you are to return to the emergency department as soon as possible
